





Number of cyberattacks on governmental entities by year










The size of cybersecurity budgets has grown across the sector

Cybersecurity spending as a percentage of total technology budget




Cyber insurance is a prominent risk transference tool despite cost growth and increasing insurance premiums

Response to whether issuers expect to buy more, the same, or less cyber insurance in 2023




Percentage change in standalone cyber insurance premiums from 2020 to 2022




Reporting requirements and notifying stakeholders

Percentage of respondents that have any cyber incident reporting requirements




Percentage of respondents that published notices over the past two years



% of the IT infrastructure hosted on public cloud


% of IT infrastructure expected be hosted on the public cloud one year from now


Cyberattacks on the educational services sector have risen in the past eight years


Baa-rated issuers has the biggest increases in their cyber budgets between 2019 and 2023



Cyber investment as a % of IT budget


By size, smaller issuers saw the greatest budget growth


